## REASONS FOR DECISION

The respondent was served with a Notice of Attendance sent by registered mail and confirmed delivered. The respondent failed to appear at the hearing and the hearing was held in his absence.

The applicant alleged that the respondent had breached the tenancy agreement by failing to pay rent and sought an order requiring the respondent to pay the alleged rent arrears. The applicant withdrew the request for an order terminating the tenancy agreement as the respondent had given notice to terminate the agreement. The premises are subsidized public housing.

The applicant provided a statement of the rent account in evidence which indicated a balance of rent owing in the amount of $\$ 2737$. The applicant also provided Public Housing Summary Reports indicating the household income and rent assessments.

I find the statement in order and find the respondent in breach of his obligation to pay rent. I find the rent arrears to be $\$ 2737$. An order shall issue requiring the respondent to pay the applicant rent arrears in the amount of \$2737.
