REASONS FOR DECISION

The respondent was served with a Notice of Attendance sent by registered mail to the rental

premises. The respondent failed to appear at the hearing and the hearing was held in her absence.

The applicant alleged that the respondent had breached the tenancy agreement by failing to pay

the full security deposit. The applicant requested an order requiring the respondent to pay the

remainder of the security deposit.

The applicant provided a copy of the tenancy agreement in evidence which indicated a required

security deposit. I find the remaining balance of the security deposit to be \$593.88.

security deposit in the amount of \$593.88.
