REASONS FOR DECISION

An application to a rental officer made by James Coxford and Alexandra Inglangasuk as the applicants/tenants against Cathy Cockney as the respondent/landlord was filed by the Rental Office February 7, 2014. The application was made regarding a residential tenancy agreement for the rental premises known as 1 Reliance in Inuvik, Northwest Territories. The applicants served a copy of the filed application package on the respondent by e-mail deemed served February 24, 2014, pursuant to section 4(4) of the *Residential Tenancies Regulations* (the Regulations).

The applicant alleged the landlord had failed to comply with her obligation to maintain the rental premises and all services and facilities.

A hearing was scheduled for April 22, 2014. Mr. Tyson Pertschy appeared at hearing representing the respondent/landlord. Mr. James Coxford and Ms. Alexandra Inglangasuk were served with notices of attendance by registered mail signed for April 9, 2014; neither Mr. Coxford nor Ms. Inglangasuk appeared at hearing, nor did anyone appear to represent them. Due to the applicants' failure to appear for the scheduled hearing, the application was dismissed.
