#### **IMPLEMENTING RULE 31-801**

## Registration Requirements and Exemptions

#### PART I DEFINITION

**1.** In this Rule, "Implementing Rule 11-801" means Implementing Rule 11-801 *Implementation of CSA Instruments* made under the Act, effective October 26, 2008, as amended.

#### PART II ADOPTION OF NATIONAL INSTRUMENTS

- **2.** (1) National Instrument 31-103 *Registration Requirements and Exemptions* of the Canadian Securities Administrators, effective September 28, 2009, is adopted and made a rule under section 169 of the Act.
- (2) National Instrument 33-109 *Registration Information* of the Canadian Securities Administrators, effective September 28, 2009, is adopted and made a rule under section 169 of the Act.

## PART III CONSEQUENTIAL AMENDMENTS TO NATIONAL INSTRUMENTS

- **3.** The following amendments made by the Canadian Securities Administrators, effective September 28, 2009, are adopted and made rules under section 169 of the Act:
  - (a) amendments to National Instrument 14-101 Definitions;
  - (b) amendments to National Instrument 24-101 Institutional Trade Matching and Settlement;
  - (c) amendments to National Instrument 31-102 National Registration Database;
  - (d) amendments to National Instrument 33-105 *Underwriting Conflicts*;

- (e) amendments to National Instrument 81-102 Mutual Funds;
- (f) amendments to National Instrument 81-104 Commodity Pools;
- (g) amendments to National Instrument 81-105 Mutual Fund Sales Practices;
- (h) amendments to National Instrument 81-107 *Independent Review Committee for Investment Funds*.

#### PART IV REPEAL OF NATIONAL INSTRUMENTS

- **4.** The following instruments made by the Canadian Securities Administrators are repealed as rules under section 169 of the Act:
  - (a) National Instrument 31-101 National Registration System;
  - (b) National Instrument 33-102 Regulation of Certain Registrant Activities;
  - (c) National Instrument 33-109 *Registration Information*, which came into force on February 21, 2003.

## PART V CONSEQUENTIAL AMENDMENTS TO LOCAL RULE

- **5.** (1) Implementing Rule 11-801 is amended by this section.
- (2) Subsections 3(4), (5), (6) and (12) are repealed.
- (3) Schedule A is amended by
  - (a) striking item 8; and
  - (b) striking "National Instrument 33-102 Regulation of Certain Registrant Activities" in item 10 and substituting "National Instrument 31-103 Registration Requirements and Exemptions".

### PART VI AMENDMENT AND REPEAL OF LOCAL RULE

- **6.** (1) Local Rule 31-501, *Registration* is amended by
  - (a) repealing the definitions "National Instrument 31-102" and "National Instrument 33-109" in section 1;
  - (b) adding the following after subsection 4(7):
- "(8) This section applies only to a person who is registered as a dealer or adviser on or before September 28, 2009."
  - (c) repealing Parts 2, 3, 6, 7 and the Schedule.

(2) Local Rule 31-501, *Registration* is repealed 6 months after this instrument comes into force.

# PART VII EFFECTIVE DATE

**7.** This instrument comes into force on September 28, 2009.
