## **IMPLEMENTING RULE 81-805**

## Mutual Funds and Non-redeemable Investment Funds

# PART I DEFINITION

**1.** In this Rule, "Implementing Rule 11-801" means Implementing Rule 11-801 *Implementation of CSA Instruments* made under the Act, effective October 26, 2008, as amended.

## PART II AMENDMENTS TO NATIONAL INSTRUMENTS

**2.** (1) Subject to subsection (2), the following amendments made by the Canadian Securities Administrators, effective September 22, 2014, are adopted and made rules under section 169 of the Act:

- (a) amendments to National Instrument 81-102 *Mutual Funds*;
- (b) amendments to National Instrument 81-101 Mutual Fund Prospectus Disclosure;
- (c) amendments to National Instrument 81-106 Investment Fund Continuous Disclosure;
- (d) amendments to National Instrument 41-101 General Prospectus Requirements.

(2) Subsection 64(3) of the amendments to National Instrument 81-102 *Mutual Funds* comes into force on January 1, 2015.

#### PART III CONSEQUENTIAL AMENDMENTS TO NATIONAL INSTRUMENTS

**3.** The following amendments made by the Canadian Securities Administrators, effective September 22, 2014, are adopted and made rules under section 169 of the Act:

- (a) amendments to National Instrument 24-101 Institutional Trade Matching and Settlement;
- (b) amendments to National Instrument 31-103 Registration Requirements, Exemptions and Ongoing Registrant Obligations;
- (c) amendments to National Instrument 33-109 Registration Information;
- (d) amendments to National Instrument 44-102 Shelf Distributions;
- (e) amendments to National Instrument 45-106 Prospectus and Registration Exemptions;
- (f) amendments to National Instrument 62-103 *The Early Warning System and Related Take-Over Bid and Insider Reporting Issues*;
- (g) amendments to National Instrument 81-104 Commodity Pools;
- (h) amendments to National Instrument 81-105 Mutual Fund Sales Practices;
- (i) amendments to National Instrument 81-107 Independent Review Committee for Investment Funds.

### PART IV CONSEQUENTIAL AMENDMENTS TO LOCAL RULE

- 4. Schedule A to Implementing Rule 11-801 is amended
  - (a) by striking "May 1, 2014" and substituting "September 22, 2014" in that portion preceding the table; and
  - (b) by striking "Mutual Funds" and substituting "Investment Funds" in item 38.

### PART V EFFECTIVE DATE

5. This instrument comes into force on September 22, 2014.
