ORDER

IT IS HEREBY ORDERED:

1. Pursuant to section 41(4)(a) of the *Residential Tenancies Act*, the respondent shall pay the applicant rent arrears in the amount of one thousand six hundred sixty four dollars (\$1664.00).
2. Pursuant to sections 41(4)(c) and 83(2) of the *Residential Tenancies Act*, the tenancy agreement between the parties for the premises known as Apartment 303, 4905 - 54th Avenue, Yellowknife, NT shall be terminated on June 30, 2011 and the respondent shall vacate the premises on that date, unless the rent arrears and the outstanding security deposit in the total amount of three thousand three hundred twenty nine dollars

(\$3329.00) are paid in full.

REASONS FOR DECISION

The respondent was personally served with a Notice of Attendance but failed to appear at the hearing. The hearing was held in her absence.

The applicant alleged that the respondent had breached the tenancy agreement by failing to pay rent and failing to pay the full amount of the required security deposit. The applicant sought an order requiring the respondent to pay the alleged rent arrears, terminating the tenancy agreement and evicting the tenant unless the rent arrears and the balance of the security deposit were paid in full.

The applicant provided a statement of the rent account which indicated a balance of rent owing in the amount of \$1664 and a balance of security deposit owing in the amount of \$1665.

I find the statement in order and find the respondent in breach of her obligation to pay rent and her obligation to provide the full security deposit. I find the rent arrears to be \$1664 and the outstanding security deposit to be \$1665. In my opinion, there are sufficient grounds to terminate the tenancy agreement unless the rent arrears and security deposit are paid in full.

An order shall issue requiring the respondent to pay the applicant rent arrears in the amount of \$1664 and terminating the tenancy agreement on June 30, 2011 unless the rent arrears and security deposit in the total amount of \$3329 are paid in full. An eviction order which will

become effective on July 1, 2011 unless the rent arrears and the remainder of the security deposit are paid in full on or before June 30, 2011 shall be issued separately.
