ORDER

IT IS HEREBY ORDERED:

1. Pursuant to section 41(4)(a) of the *Residential Tenancies Act*, the respondent shall pay the applicant rent arrears in the amount of six hundred ninety nine dollars (\$699.00).
2. Pursuant to sections 41(4)(c) and 83(2) of the *Residential Tenancies Act*, the tenancy agreement between the parties for the premises known as Apartment 205, 600 Gitzel Street, Yellowknife, NT shall be terminated on June 30, 2011 and the respondent shall vacate the premises on that date, unless the rent arrears are paid in full.

REASONS FOR DECISION

The respondent was personally served with a Notice of Attendance but failed to appear at the hearing. The hearing was held in his absence.

The applicant alleged that the respondent had breached the tenancy agreement by failing to pay rent. The applicant sought an order requiring the respondent to pay the alleged rent arrears, terminating the tenancy agreement and evicting the tenant unless the rent arrears were paid in full.

The applicant provided a statement of the rent account which indicated a balance of rent owing in the amount of \$714. The statement contains some double-entries for rent penalties totalling \$15. The applicant acknowledged that the balance owing should be \$699.

I find the respondent in breach of his obligation to pay rent and find the rent arrears to be \$699. In my opinion, there are sufficient grounds to terminate the tenancy agreement unless the rent arrears are paid in full.

An order shall issue requiring the respondent to pay the applicant rent arrears in the amount of \$699 and terminating the tenancy agreement on June 30, 2011 unless the rent arrears are paid in full. An eviction order which will become effective on July 1, 2011 unless the rent arrears are paid in full on or before June 30, 2011 shall be issued separately.
