2. Pursuant to section 41(4)(b) of the *Residential Tenancies Act*, the respondent shall pay future rent on time.

3. Pursuant to section 45(4)(a) of the *Residential Tenancies Act*, the respondent shall comply with her obligation to report the household income in accordance with the tenancy agreement.

REASONS FOR DECISION

The respondent was served with a Notice of Attendance sent by registered mail and confirmed delivered. The respondent failed to appear at the hearing and the hearing was held in her absence.

The applicant alleged that the respondent had breached the tenancy agreement by failing to pay rent and by failing to report the household income in accordance with the tenancy agreement. The applicant sought an order requiring the respondent to pay the alleged rent arrears, to pay future rent on time and to comply with her obligation to report the household income in accordance with the tenancy agreement. The premises are subsidized public housing.

The applicant provided a statement of the rent account in evidence which indicated a balance of rent owing in the amount of \$2071.

The full unsubsidized rent has been assessed in September, 2012. The applicant stated that the respondent had not provided any household income information to enable the calculation of a subsidized rent for that month.

I find the statement in order and find the application of the full unsubsidized rent to be reasonable. I note however that should the respondent report the household income, the applicant is obligated to adjust the rent in accordance with the reported income and the rent scale. I find the respondent in breach of her obligation to pay rent and to report the household income. I find the

rent arrears to be \$2071.

An order shall issue requiring the respondent to pay the applicant rent arrears in the amount of \$2071, to pay future rent on time and to comply with her obligation to report the household income in accordance with the tenancy agreement.
