ORDER

IT IS HEREBY ORDERED:

1. Pursuant to section 63(4)(b) of the *Residential Tenancies Act*, the respondent shall pay the applicant compensation for use and occupation of the rental premises as follows:
 - a) For the period July 1, 2012 to October 30, 2012 the amount of three thousand four hundred fifty six dollars (\$3456.00) and
 - b) for each day in October, 2012 after October 30, 2012 that the respondent remains in possession the amount of twenty eight dollars (\$28.00) and
 - c) for each day in November, 2012 that the respondent remains in possession, the amount of twenty nine dollars and three cents (\$29.03).

REASONS FOR DECISION

The respondent was personally served with a Notice of Attendance but failed to appear at the hearing. The hearing was held in his absence.

The premises are subsidized public housing. The parties entered into a term tenancy agreement commencing on June 1, 2012 and ending on June 30, 2012. A notice was served on the respondent on June 12, 2012 stating that the tenancy agreement would not be renewed. No new tenancy agreement was formed after June 30, 2012.

The applicant sought an eviction order and an order requiring the respondent to pay compensation for use and occupation of the rental premises after June 30, 2012 at the unsubsidized rental rate of \$871/month.

Section 51(4) of the *Residential Tenancies Act* sets out the following provision for termination of a tenancy agreement for public housing made for a term of 31 days or less:

- 51. (3) Where a tenancy agreement for subsidized public housing specifies a date for termination of the agreement, the landlord may terminate the tenancy on the date specified in the agreement by giving the tenant a notice of termination not later than 30 days before that date.**
- (4) Notwithstanding subsection (3), where a tenancy agreement for subsidized public housing specifies a date for termination of the agreement that is 31 days or less after the commencement of the agreement, it terminates on the specified date.**

The Act does not require a reason or a notice pursuant to section 51(4).

I find that the tenancy was terminated on June 30, 2012 in accordance with the provisions of section 51(4) of the Act. The respondent has been overholding since that date.

An order shall issue requiring the respondent to pay compensation for use and occupation of the premises after June 30, 2012 as follows:

- a) For the period July 1 - October 30, 2012

July - September 30, 2012 @ \$871/month =	\$2613
October 1-30 @ \$871/month =	<u>843</u>
	\$3456

- b) For each day in October, 2012 after October 30 that the respondent remains in possession of the premises - \$28
- c) For each day in November, 2012 that the respondent remains in possession of the premises - \$29.03

An eviction order shall be issued separately.
