ORDER

IT IS HEREBY ORDERED:

1. Pursuant to section 41(4)(a) of the *Residential Tenancies Act*, the respondent shall pay the applicant rent arrears in the amount of three thousand eighty nine dollars and ninety one cents (\$3089.91).
2. Pursuant to sections 41(4)(c) and 83(2) of the *Residential Tenancies Act*, the tenancy agreement between the parties for the premises known as 5438 - 52nd Street, Yellowknife, NT shall be terminated on March 31, 2014 and the respondent shall vacate the premises on that date unless the rent arrears and the March, 2014 rent in the total amount of five thousand thirty four dollars and ninety one cents (\$5034.91) are paid in full.

REASONS FOR DECISION

The applicant alleged that the respondent had breached the tenancy agreement by failing to pay rent. The applicant sought an order requiring the respondent to pay the alleged rent arrears and terminating the tenancy agreement and evicting the respondent.

The applicant provided a statement of the rent account which indicated a balance of rent arrears in the amount of \$3089.91. The monthly rent for the premises is \$1945 and the applicant holds a security deposit of \$1945.

The respondent did not dispute the allegations. The applicant stated that they would agree to continue the tenancy provided the rent arrears and the March rent were paid in full on or before March 31, 2014.

I find the statement in order and find the rent arrears to be \$3089.91. In my opinion, there are sufficient grounds to terminate the tenancy agreement unless the rent arrears are promptly paid.

An order shall issue requiring the respondent to pay the applicant rent arrears in the amount of \$3089.91 and terminating the tenancy agreement on March 31, 2014 unless the rent arrears and the rent for March, 2014 in the total amount of \$5034.91 are paid in full.

An eviction order to be effective on April 1, 2014 unless the rent arrears and the rent for March,

2014 in the total amount of \$5034.91 are paid in full on or before March 31, 2014 shall be issued separately.
