**REASONS FOR DECISION**

This eviction order is issued in conjunction with Rental Officer order number 20-14274 dated December 1, 2014, and the reasons for decision therein attached include reasons for the issuance of this eviction order. Refer to that order and reasons for decision for a detailed accounting of this matter.

Having found justification for conditional termination of the tenancy agreement between Ulukhaktok Housing Association and Joshua Oliktoak, and having ordered said termination for January 31, 2015, unless certain conditions have been met, I have also found justification for issuing an eviction order to remove Mr. Oliktoak from the rental premises known as Unit 092 in Ulukhaktok, Northwest Territories, on February 1, 2015, if the tenancy terminates January 31, 2015.
