REASONS FOR DECISION

An application to a rental officer made by Satdeo Inc. as the applicant/landlord against Kim Giroux as the respondent/tenant was filed by the Rental Office December 4, 2014. The application was made regarding a residential tenancy agreement for the rental premises known as #302, 3 Capital Drive, in Hay River, Northwest Territories. The applicant personally served the respondent a copy of the filed application December 11, 2014.

The applicant alleged the respondent had accumulated rental arrears and sought an order for payment of rental arrears and termination of the tenancy agreement. No documentary evidence was submitted.

A hearing was scheduled for January 21, 2015, in Hay River, Northwest Territories. Mr. Blaine Maillet appeared representing the applicant. Ms. Kim Giroux was served a notice of attendance by registered mail deemed served January 12, 2015, pursuant to section 71(5) of the *Residential Tenancies Act* (the Act). Ms. Giroux did not appear at hearing, nor did anyone appear on her behalf. The hearing proceeded in her absence pursuant to section 80(2) of the Act.

Mr. Maillet testified that Ms. Giroux had a verbal tenancy agreement with the landlord for the rental premises known as #302, 3 Capital Drive, in Hay River, Northwest Territories. The current agreed upon monthly rent was \$1,200. Ms. Giroux vacated the rental premises approximately one month prior to this hearing date, leaving rental arrears in the amount of \$2,000. Mr. Maillet requested an order for payment of rental arrears.

Having nothing before me to dispute the applicant's claim, I find Ms. Kim Giroux has accumulated rental arrears in the amount of \$2,000 and an order will issue requiring payment of the rental arrears.
