REASONS FOR DECISION

This eviction order is issued in conjunction with Rental Officer order number 10-14678 dated July 7, 2015, and the reasons for decision therein attached include reasons for the issuance of this eviction order. Refer to that order and reasons for decision for a detailed accounting of this matter.

Having found the tenancy agreement between NWT Housing Corporation as the landlord and Paul Catholique and Bernice Marlowe as the tenants terminated March 31, 2015, in accordance with the *Residential Tenancies Act* and determining that the tenants remain in occupancy of the rental premises, I have found justification for issuing an eviction order to remove Mr. Catholique and Ms. Marlowe from the rental premises known as Unit #237 in Lutselk'e, Northwest Territories, on August 1, 2015.
