REASONS FOR DECISION

The respondent was served with a Notice of Attendance sent by registered mail and confirmed delivered. The respondent failed to appear at the hearing and the hearing was held in her absence.

The applicant alleged that the respondent had breached the tenancy agreement by failing to pay rent. The premises consist of a mobile home park lot. The applicant sought an order requiring the respondent to pay the alleged rent arrears and to pay future rent on time.

The applicant provided a statement of the rent account which indicated a balance of rent as at June 1, 2015 of \$3710. The applicant stated that since that date the July rent had come due (\$260), the August rent had come due (\$260) and a payment of \$520 was made on July 31, 2015 bringing the balance owing to \$3710.

I find the respondent in breach of her obligation to pay rent and find the rent arrears to be \$3710. An order shall issue requiring the respondent to pay rent arrears of \$3710 and to pay future rent on time.
